Whereas in consideration for being allowed to use the facilities of the Bearcamp Valley Sportsmen's Club (hereinafter referred to as 'the Club') the undersigned agrees to the following;

Undersigned agrees to indemnify, hold harmless and defend the Officers and Board Members of the Club from any and all fault, liabilities, costs, expenses, claims, demands or lawsuits arising out of, related to, or connected with: the Undersigned's presence on or use of the firing range, land, buildings and premises of the Club and any and all acts or omissions of the undersigned, their family members or guests, including all acts of negligence with any firearm in their possession.

Undersigned furthermore waives for himself/herself and for his/her executors, personal representatives, administrators, assignees, heirs and next of kin, any and all rights and claims for damages, losses, demands and any other actions or claims whatsoever, which he or she may have or which may arise against the Club (including but not limited to the death of Undersigned or any and all injuries, damage or illness suffered by Undersigned or Undersigned's property), which may, in anyway whatsoever, arise out of, be related to or in any way connected with; the premises, including any latent defect in the premises, Undersigned's property, and or the discharge of any firearms. The Officers and Board Members of the Club shall not be liable for, and Undersigned, on behalf of himself/herself and on behalf of his/her executors, personal representatives, administrators, assignees, heirs and next of kin, hereby expressly release the Officers and Board Members of the Club from any and all claims and liabilities.

Undersigned hereby acknowledges and agrees that Undersigned has read this instrument and understands its terms and is executing this instrument voluntarily. Undersigned furthermore hereby acknowledges and agrees that he/she has read understands and will at all times abide by all the Club general rules and range rules.

Understand expressly agrees that this instrument is intended to be as broad and all-inclusive as permitted by law and that if any provision of this instrument is held invalid or otherwise unenforceable, the enforceability of the remaining provisions shall not be impaired thereby. No remedy conferred by any of the specific provisions of this instrument is intended to be exclusive of any other remedy, and each and every remedy shall be cumulative and shall be in addition to every other remedy now or in equity or by statute or otherwise. The election of any one or more remedy hereunder by the Officers and Board Members of the Club shall not constitute any waiver of Officers and Board Members of the Club rights to pursue other available remedies. This instrument binds Undersigned and his/her executors, personal representatives, administrators, assignees, heirs and next of kin. Adults (over 18) shall sign their own waiver.
